Improving communication

Creation of Emmaus Europe's own website

The year 2008 saw an ongoing discussion between the Secretariat of EE, the graphic designer and the Emmaus Europe's website developer.

Its construction was the object of many debates.

A little over a year after the Regional Assembly in Strasbourg (August 2007), which called for a specific website for the European Region to be set up, it was launched at the beginning of 2009.

One of the priorities set by Emmaus Europe's highest authority was indeed the improvement of the association's

communication through, among others, the creation of a website.

The website has been online since 1st January 2009: it is dedicated to improving communication between groups and Emmaus Europe, but also between the groups themselves.

A directory of groups

is now available via an interactive map of Europe showing the countries where Emmaus is present: visit the section "Directory of groups".

A members' area

was also created to meet the needs of internal communication. In addition, discussions for debates reserved the member between groups and the elected representatives in Emmaus Europe's website forum. You can access to it using the login name "eemmaus" password "ee2005".

Monitoring the French Presidency of the EU

Establishment of a watchdog common to Emmaus Europe and Emmaus France in light of the French Presidency of the European Union.

A letter was distributed every month during the second half of 2008: "1, 2, 3, 4, 5, 6 EUROPE".

One of its objectives was to inform the European groups

about how the European Union's work was progressing and its impact on the actions of groups.

Training and New Generations

In 2008, four European representatives proposed activities related to the theme of the training and to the issue of new generations.



Training on Migration and migration policies: what are the issues at stake for Emmaus?

Following requests made at the Emmaus Europe Regional Assembly in 2007, the European members of the World Council on Training and New Generations, in partnership with the Regional Secretariat, thought that it was time for the members of Emmaus Europe to get to know each other and to work together. This is why the first European training course, held in Ferrara in May, focused on this priority issue for Emmaus Europe.

The International Training Camp on Sustainable Development

An event at a European level was organized at the Lusophone University of Lisbon (Portugal). The Movement chose to devote this time for information and training to this issue in which the Emmaus groups have been involved for many years. Since the International Training Camp in Lisbon in October 2008 took place in Europe, the Europe Region was associated with Emmaus International in its organization and development.

It brought together 35 participants from fifteen countries: Italy, France, Finland, Portugal, Spain, Sweden, Ukraine, India, Lebanon, Chile, Uruguay, Benin, Burkina Faso, Burundi and South Africa.



Regional solidarity

Intra-European solidarity operated in 2008, as in previous years, with the economic, material and human resources contributions of many groups.

Emmaus Salon in Paris, June 2008

Many European groups participated in the Paris Salon in 2008.

Among the countries represented were: Switzerland, Belgium, Italy, Poland, Ukraine, Romania, Germany, UK, and the Netherlands.

The Europe Region was represented by a stand showing the activities and commitments in Europe.

The convoys

In 2008, as in previous years on the occasion of the International Youth Camp held in Bosnia during the summer, a convoy organized for the local population. Composed of seven trucks on loan and chartered bv various communities, this convov contained furniture, clothes and objects of all kinds, things that may be useful to people from that country in reconstruction.

Intra-European containers program

The Secretariat of Emmaus Europe serves as an interface between the groups Emmaus Europe that passed along their needs in terms of equipment and those who volunteer to make shipments. Thus the Secretariat has followed up and gathered information throughout 2008. European Collectives: working groups in charge of the solidarity of the Region

Shortly after the creation of Emmaus Europe, it was decided to provide a framework of European coordination to the long-time-existing solidarity ties between groups of Western and Eastern Europe.

The idea was not to replace what already existed, but to facilitate joint work between those working in the field and their partners.

The objective is thus to organize solidarity actions for groups in the East, in a framework of transparency and sustainability.

All of these solidarity actions are handled by the Collective in charge of the supported country, together with the Regional Executive and the Secretariat of Emmaus Europe. The Collective

transmits the positions agreed by the Movement to the groups and is the spokesperson for the actions and proposals of the groups in the Movement's bodies.

In 2008, the Collectives have continued their solidarity actions for one country in particular through calls for solidarity sent by Emmaus Europe to all European groups.



The Bosnia Collective

Actions supported in 2008:

International Forum of Solidarity, Bosnia

- Organization of an International Youth Camp and convoy in Srebrenica. Objective: To provide for the expenses of young participants staying at the camp and for the expenses of the convoy.
- European Centre of civil services to the population of Srebrenica: Fundraising for the purchase of a plot of land for the creation of this centre offering social, economic, cultural and ecological activities.

The Poland/Ukraine Collective

Actions supported in 2008: Emmaus Rzeszów, Poland

- Fundraising for the purchase of a plot of land for building the community house and improving the lives of companions.
- Isolation of the attic's roof in the shop to improve sheltering conditions for the companions and the clients.

Emmaus Lublin, Poland

• Fundraising for the reconstruction of the carpentry workshop in order to complete the work and equipping of the workshop for the official opening of the social carpentry enterprise to achieve self-sufficiency.

Mutual Aid Community Oselya, Ukraine

- Fundraising for the rehabilitation of a building for rent.
- Support for the remuneration of 5 employees in 2008 to contribute to the stability, management and organization of the community.

Migration and Human Trafficking Collective

This group is working on the issue of migration and human trafficking, as part of the development of Emmaus Europe's citizen actions. During 2008, the Collective's action has focused on activities and demonstrations for the rights of Migrants. The fight against human trafficking continued through the actions supported in Lithuania by the prevention program monitored by the Missing Persons Family Support

Summer volunteering: youth camps in Europe

The groups that hosted young people in 2008 are in Belgium, Bosnia, France, Germany and Italy.

Political actions and regional alliances

During 2008, the European Region committed to defending the rights of migrants.

Co-organization of the Citizen Summit on Migration and Mobilization of all the European Emmaus groups

The objective of the summit: make the voice of civil societies from Europe and Africa heard and denounce the agreements of the European Pact proposed by the French Presidency of the European Union and adopted by the European countries. France promotes a selective immigration and seeks to compel the South to readmit their expelled nationals.

This citizen mobilisation was held over two days:

• On Friday, October 17th, 2008 the second Euro-African non-governmental conference was held: the day featured an opening plenary session, 6 thematic workshops (North-South relations; selective migration; freedom of circulation; migrant women; minors in migration; right of asylum) and a closing plenary session, during which a Euro-African statement was adopted. Renzo Fior, Manager of the community of Villafranca (Italy) and

President of Emmaus Italy was the speaker for the Emmaus Movement.

• On Saturday, October 18th, 2008 a festive march, followed by a concert allowed the concerns of citizens towards the European migration policy to be expressed.

The summit was also an opportunity to submit alternative proposals before the Euro-African interministerial conference on migration and development on November 25th bringing together both African and European

Therefore, citizens' organizations were present on the day of the conference near the conference location to protest against the rejection of dialogue and to try once again to be received at the Summit to present the alternatives that we defend, and give them media coverage. Emmaus, of course, was there.

Mobilization against the *Outrageous Directive*

The work of Emmaus Europe took place in several stages:

• April – Signing the joint appeal: Emmaus Europe, along with Emmaus International and Emmaus France, signed an appeal to MEPs (Members of the European Parliament) to reject the draft directive.

• April – In addition, a model *letter* was sent to all the European Emmaus groups. *Addressed to the MEPs*, the letter aimed to raise the awareness of each MEP about the dangers involved in the draft directive. The Emmaus groups based in the EU Member States got involved by sending the letter to their MEPs.

- May Joining the demonstration on May 7th in Brussels: the Outrageous Directive should have been submitted for approval on May 20th 2008. Consequently, a demonstration, in which Emmaus Europe participated, was organized on May 7th 2008 in Brussels to protest against the adoption of the directive and the ensuing measures. In the end, an amendment was proposed and the vote was delayed until June 18th 2008.
- May *Joining the demonstration on June 14th in Paris:* following the postponement of the European Parliament vote, a second demonstration was held in Paris on June 14th 2008. An appeal to join the demonstration was sent to the European Emmaus groups.
- **June** *A press release* signed by the *presidents of Emmaus Europe* and *Emmaus International* was distributed on June 19th 2008, to protest against the adoption of the Outrageous Directive.
- June Participating in the Development Research and Information Centre colloquium on June 27th on the topic of "Migration and development: the issues and pitfalls of codevelopment."

The Returns Directive, which has been christened the Outrageous Directive, was put forward for adoption to the European Union Council of Ministers on December 8th 2008, two days before the 60th anniversary of the Universal Declaration of Human Rights.

So as to request the postponement of the vote and the abandonment of the directive, a *letter* was sent to the President of France and to several French ministers, who held the EU Presidency at that time.

- Two Regional Councils of Emmaus Europe: March and October.
- Four Regional Executive meetings: in Alfortville, in Brussels and in Montreuil.
- Two conference calls between the members of the Regional Executive were held.
