1) Words of welcome and information about replacing the resigning CEIs. Approval of the previous meeting's minutes.	Nika no longer wishes to be a CEI because of the AP issues and a conflict of interest with her work. CNZD supports child victims of violence. Aurore stopped working for Emmaus on 28 November and her contract will end for good in February. Jerry Marguerite from Servas in France and Nick Thompson from Emmaus Merseyside (UK) have been potential replacements since the last GA. They have discussed the matter with their respective communities and agree to replace the departing members. Awaiting more information in time for the February exec. The EE Regional Executive will no longer have any French members following Aurore's departure. We need to coopt someone from France, preferably a woman who could try out the role and become a member of the Board in 2026. The name of Aurélie Gillmann, who provided an excellent report of the RAEE for the Val de Loire Region, was mentioned at the lunch break as a very good potential substitute. 6) Implementation of the WFA initiatives: Approval of the volunteer's remit	Europe's proposal Four initiatives chosen by the RCEE. The meeting discussed the sort of person needed, and the contribution that this person could make to the team. The challenge is to ensure that the person feels useful, quickly grasps the movement, and works quite independently to create their own role, in conjunction with Eve. Challenges involved in filling the post For EE, ensure that it helps us with our work, without being a burden. It also needs to be a plus for the groups, but this is not a given. Lisa, a member of the WFA Youth Delegation has been contacted. She has the necessary skillset and might be interested if she could continue her part-time role at Emmaus Mundo. Her CV was examined. Agreement in principle. Follow up with EI regarding terms of employment.	
7) Solidarity: ASP projects/Ukraine (Docs)	 Emmanuel provided an update about the Ukraine Fund: Remaining funding, Oselya's monthly support requests, and Oselya's plans for 2025. The meeting started a discussion about developments to the Ukraine Fund, based on the different Oselya projects (see memo about the projects). Emmanuel presented Grigory's and Natalia's opinion about the fund: 	Oselya's monthly funding support request (€12,089.31 for three months) approved by the executive.

- The monthly support needs to continue until Oselya finds financial partners to replace Emmaus Europe.
- Funding Oselya's projects helps promote the Emmaus model in Ukraine, and these projects help to promote peace. Their economic base is broader thanks to the various forms of support provided by EE.
- A Zoom meeting will be held with Natalia and Grigory to mark the third anniversary of the start of the war and will enable news to be passed on to the European groups. The EE executive selected the 24 February for the meeting.
- The elected representatives felt that support for Oselya should be maintained, while retaining a budget for the post-war period. Oselya's development projects are very interesting and enable support to be provided for a large number of conflict victims.
- Herbert wants to visit Natalia and Grigory in March.
- Emmanuel presented the five solidarity projects submitted for 2025 (see memo for details about the projects).
- Emmaus-ISF (Bosnia-Herzegovina): This project could be funded via EI or EE, with a contribution from the Green Transition Fund.
- Emmaus Geo (Georgia): The group is in contact with a large number of groups in Eastern France. The project does not have a specific timescale and could be funded by European solidarity.
- TOMS (Croatia): Service at a symbolic price for members and beneficiaries (cost of fuel). The people carrier could be used to provide a paid taxi service the rest of the time.
- Poland Brat Albert: More information is required, but an option would be to help the group to rent premises in the town while the building work takes place.
- Brighton UK: Fit solar panels
- Total budget: €59,882
- Funding requested: €29,947
- The group had submitted two funding applications to the FAP but they were rejected. The group has received funding from Emmaus UK over the past three years.
- The meeting discussed whether it was possible to receive national and international funding at the same time. The elected representatives agreed that decisions on this matter should be taken on a case-by-case basis.
- Regarding Brighton's application, an idea could be to split it into a loan application to the Emmaus Ethical Fund for some of the requested funding, and submit the rest of the amount being sought for FAP/international/European solidarity funding.

- The exec approved the holding of a Zoom meeting with Oselya on 24 February.
- The executive approved the principle of supporting Oselya's development projects in 2025.
- Presentation of the five projects to the March RCEE and in February (an elected representative will work on each project with Emmanuel)

For public funding, an idea would be to get the Green Transition Fund co-funded with public/EE funding and this could be expanded to the European Solidarity Programme. The potential idea of public funding for energy efficiency work could also be examined. Marie Lucas said that there was the possibility of splitting a project's funding application between an ASP application and a Green Transition Fund application. 11) European advocacy: Roundtable - what is the impact of the textile crisis in your country?	 The textile crisis - Roundtable about the situation in each country Netherlands: Critical situation (cost of sorting/kilo increased from €20 to €50). Switzerland: Difficult to influence the path taken by waste owned by the big groups, and it is hard to resell poor-quality items. Finland: Millions of euro of investment to work with universities, creation of robotic sorting facilities. Plan to open a kilo shop to sell the amounts received, as they are increasing every year (120 tonnes a year). UK: Textile and environmental policies are not a priority for the government at the present time. Romania: No waste sorting sector. Legislation on cleaning textiles generating an increase in second-hand clothing and other textile product prices making the sector inaccessible. Swedish example: Local councils manage textile waste and run calls for projects. France: Proposal to incinerate all waste. Belgium: Social enterprises are reduced to renting warehouses to store textiles. Update on the work done by RREUSE (see documentation supplied) Get ready for the demonstration in front of the European Parliament in Brussels to raise awareness about textile overproduction and about the situation of social economy stakeholders in the current textile crisis. Invite all the Board members who wish to take part. Attendance confirmed: Carina, Yvette and a Dutch delegation, Jean-Philippe if we meet with the Romania commissioner. Arrange a webinar for 4 February focusing on our place in the new industries following the implementation of separate textile collection.
