Membership dues scale approved by the Manchester Regional Assembly, 3 September 2015.

• Sales income below €50,000	€55
• Sales income between €50,000 and €100,000	€165
• Sales income between €100,000 and €200,000	€550
• Sales income between €200,000 and €300,000	€1,100
• Sales income between €300,000 and €500,000	€1,650
• Sales income between €500,000 and €1,000,000	€2,200
• Sales income over €1,000,000	€3,300

A voluntary contribution is requested from groups with no financial resources or groups that do not sell goods, with the amount being decided at the group's own discretion.

Trial member groups: 25% of the membership dues amount
