We are facing many challenges in 2025, with a number of draft European laws on the table of the new Parliament and new European Commission which we will be focussing on:

- A new plan for the circular economy
- A draft European anti-poverty strategy

We are also continuing to take action to tackle discrimination and promote peace against an increasingly tense backdrop. We hope to see many of you at the second Emmaus Europe Football Championship for Peace and Human Rights! This year it will be held in Dijon, France on 22 - 23 July, and will help forge ties between Emmaus groups in Europe over a game of football, as well as providing training in non-violent action and deciphering fake news, which raises tensions in our groups and elsewhere.
